Findings of Fact:

Within any Design Control Overlay area, no structure may be erected, reconstructed, substantially altered, restored, moved, demolished, or changed in use or type of occupancy without design approval of plans by the Development Review Board.

Summary of Discussion:

This parcel was awarded a 2023 VT Historic Preservation Barn Grant in the amount of \$15,000. The Grant was refused. The Builder and the owner worked together to prepare the Grant in May 2022. In 2023, the Owner asked the Builder to cover a few holes in the barn roof to avoid further damage. He found that there was no roof left in several areas. They concluded that the structure was beyond salvage at that time.

Decision and Conditions:

After discussion and consideration and with great respect for historic buildings, such as this barn, the preponderance of the testimony from the Applicant, Rob Balivet, and the Builder, Bob Magro motioned to approve the permit to demolish. Seconded by Larry Rossi. As all are in favor, without objection, the permit is approved.

An approved permit will be issued once the 30-day appeal period has passed, pending any appeals.
