Findings of Fact:

Sec 516, Low Density Residential: Man-made pond is a Conditional use in the LDR District.

Summary of Discussion:

This pond will be fed by an existing spring, which runs under Wheelock Rd through an existing culvert. The applicant may possibly cut some cedar trees to expand the pond area. The pond will include a dry hydrant, which was appreciated by the Danville Fire Chief.

While it appears that a pond of this size does not require a Vermont permit, the presence of wetlands could be a concern, given the adjacent cedar trees.
